Customer data processing, accommodation of private customers

In this privacy policy we explain how we process personal data. With this policy, we inform the data subject (hereinafter referred to as You) about how we process your personal data, what rights you have and how you can exercise your rights. The content of the statement, the rights of the data subject, etc. is laid down in the EU General Data Protection Regulation 2016/679.

The processing of personal data refers to activities that are directed at a natural person, e.g. Your personal data or sets of personal data. The processing of personal data can take place in information systems or manually, for example on paper or by conversation. The processing of personal data includes, among other things, the collection, recording, organisation, storage, modification, transfer, combination, disclosure, publication of data, as well as the deletion and destruction of data.

Purpose of processing

Customer data is used for accommodation services, such as handling reservations, payments, payment monitoring and collection. Marketing of Santasport's goods and services, business development and the development of customer services related to it.

Legal basis for processing

The processing of personal data is based on the customer relationship that arises when a person makes a reservation for accommodation or stays at the hotel. Provisions on the processing of accommodation data are laid down in the Act on Accommodation and Food Service Activities 308/2006 (FIN).

The processing of personal data for marketing purposes is based on consent, which the customer can give when booking accommodation on the website (by ticking a box).

Retention period of personal data

1-3 years
